**OUR TERMS OF BUSINESS AND PAYMENT TERMS**

For our Traditional Funeral Service, we request that an initial payment of the disbursement (third party costs), or 50% of the total estimated funeral costs, whichever is greater, is paid to us prior to the funeral taking place. A final invoice will be sent out within 14 days of the funeral taking place. The balance is due within 30 days of the funeral. For the Simplicity Funeral and Unattended Funeral, we require payment in full prior to the funeral taking place.

5% credit surcharge will become due on any overdue amount not paid within 90 days of the funeral and then 1% compound interest charged on the amount outstanding.

If we use the services of a debt collection agency, a further 15% is added to the amount outstanding. Payment can be made by credit or debit card, cheque, BACS or cash.
